RULES AND REGULATIONS FOR THE USE OF THE PLAYGROUND

- 1. The playground is used for **play, recreation and leisure** by school children and youth. By entering the playground you accept these Rules and Regulations and undertake to comply with them.
- 2. Children **under 7 years of age** are only allowed on the playground when accompanied by a **parent or guardian.**
- 3. Their parents or guardians are responsible for damage caused by minors.
- 4. Play equipment must be used in accordance with its intended use and, in addition, the following rules must be observed for the safety of those playing:
 - team games and cycling are prohibited in the vicinity of the play equipment;
 - it is forbidden to climb on the top of playground equipment; this applies in particular to the swings, tyrolean, and horse mill;
 - it is forbidden for more than one person to use the tyrolean or the single swing seat at the same time.
- 5. Users of the playground use it at their own risk. Kopalnia Soli "Wieliczka" S.A. is not liable, in particular, for any damage resulting from using the playground in a manner inconsistent with these Rules and Regulations or resulting from failure to provide care for a child present on the playground.
- 6. On the playground it **is prohibited**:
 - littering the area;
 - destruction of and damage to vegetation;
 - vandalism of play and recreational equipment and fences;
 - disturbing the peace and public order;
 - burning of bonfires, barbecuing and use of pyrotechnics and harmful chemicals;
 - making entry of animals;
 - bringing in dangerous objects;
 - eating on play equipment;
 - consumption of alcoholic beverages or other intoxicants, the presence of intoxicated persons;
 - smoking or using tobacco products, electronic cigarettes or novelty tobacco products.
- 7. It is forbidden to cause situations that endanger one's own safety, the safety of others using the playground or situations that may cause an accident, and in particular:
 - organizing of baths;
 - climbing on structural elements of the attractions on the playground area;

- use of the playground or part of it if access is closed off by a chain or rope;
- being naked on the playground area;
- running without suitable footwear;
- use of detergents and cosmetics that could pollute the water.
- 8. The water flowing through the water playground equipment is not drinkable.
- 9. All persons violating the provisions of these Rules and Regulations and any other rules and regulations applicable to the playground may be removed from the Brine Graduation Tower facility.
- 10.For technical reasons or during bad weather conditions, in particular storms, lightning, very strong winds, etc., the playground may be closed in whole or in part.
