AUTOMATED PAID CAR PARK - TERMS AND CONDITIONS OF ENTRY AND PARKING

I. ORGANISATION OF THE CAR PARK

- 1. The car park is operated by Kopalnia Soli "Wieliczka" S.A., hereinafter referred to as the Operator.
- 2. The car park is open from 6:00 a.m. until 10:00 p.m. on all days of the week (with the exception of 1 January, Easter Sunday, 1 November, as well as 24 and 25 December). The Operator reserves the right to close the car park on other days, as well as change the opening hours of the car park by either shortening or extending the opening time, of which the car park users will be informed before entering the car park.
- 3. By entering the area of the car park in a motor vehicle, every car park user agrees to the terms and conditions of these Terms and Conditions and undertakes to observe their provisions.

II. ENTRY, PARKING AND DEPARTURE CONDITIONS

- 1. By entering the car park, as the user of the car park (hereinafter referred to as "the user") you conclude a paid parking space lease agreement with the Operator. The agreement expires upon leaving the car park.
- 2. At the moment of entering the car park, the User pulls up to the ENTRY BARRIER. The User COLLECTS THE ENTRY TICKET.
- 3. The barrier will be opened automatically after the scanner reads the registration plates of the vehicle upon collection of the entry ticket.
- When the entry barrier is opened, the User parks their vehicle in a vacant parking space.
- 5. In order to leave the car park, the User has to pay a parking fee at one of the two car park payment booths located in the car park. Payment for parking is made by entering the registration number of the vehicle or by scanning the entry ticket on the panel of the payment booth and paying the relevant fee.
- 6. After payment, the User may leave the car park.
- 7. The time between payment of the parking fee and departure is 15 minutes (once this time is exceeded, the User will be charged another parking fee).
- 8. The departure barrier is opened automatically (after payment of the parking fee) when the vehicle pulls up to the departure terminal and stops in front of the departure barrier or after scanning the entry ticket.
- 9. If the automatic barrier opening system is not working or if the User is unable to pay for the parking ticket at the payment booth, the User has to pay at the exit terminal using a credit or debit card the barrier will open automatically.
- 10. In order to contact support, both the terminals and the payment booths are equipped with intercoms which enable contact with car park staff.
- 11. The owner of an electric vehicle who intends to use the charging station only needs to inform the car park staff via the intercom in order to enter the registration number of the vehicle into the car park system and allow the vehicle to leave the car park area free of charge once the charging of the vehicle has been completed.

III. PRICE AND PARKING TIME

- A one-off charge applies each time a User parks their vehicle between 6:00 a.m. and 10:00 p.m. (in line with the price list).
- 2. The charge for vehicle entry and parking in the car park is calculated in line with the price list described above.
- 3. The vehicle may only leave the car park after payment of the parking charge and any additional fees.
- 4. If the user leaves their vehicle in the car park after 10:00 p.m., an additional charge will apply, in line with the price list. In order to be able to leave the car park area after 10:00 p.m., the User is required to contact the telephone number provided in a visible place at the entrance to the car park area. The Operator's security staff will allow the User to leave the car park area after confirming that the User has paid the parking fee and any additional fees.
- 5. If the vehicle is left for a longer time, i.e. from 6:00 a.m. to 10:00 p.m. on the following day, in addition to the previous day's parking charge and an additional fee, another parking charge will be levied, according to the price list. The charges are added up.
- 6. Payment for parking is made prior to departure at the automated payment booth. It is charged for each vehicle identified by its registration number.
- 7. Payment can be made by credit/debit card or cash.

Payments are processed by Centrum Elektronicznych Usług Płatniczych eService sp. z o. o. with its registered office in Warsaw, Jana Olbrachta 94, 01102 Warsaw, entered in the register of entrepreneurs kept by the District Court for the Capital City of Warsaw Warsaw, XII Commercial Division of the National Court Register under KRS number: 0000490970, NIP (National Business Registry Number): 1181477610, REGON (National Business Registry Number): 016107240, share capital 56,000,000 PLN, a national payment institution within the meaning of the Payment Services Act of 19 August 2011, entered in the Payment Services Register under number IP7/2013.

IV. LIABILITY

- 1. The Operator shall not be liable for damage due to theft, loss or destruction of the vehicle, as well as items left in the vehicle, during the period the vehicle is parked in the car park.
- 2. The User shall be responsible for any damage caused in the car park, including to other Users and third parties.
- 3. The User is obliged to immediately inform the car park staff of any damage caused and/or incurred in the car park no later than before leaving the car park.
- 4. Failure to comply with these Terms and Conditions, in particular a failure to pay the relevant fee will result in the inability to leave the car park until all relevant fees have been paid.
- 5. Dangerous vehicles and any vehicles parked outside the designated areas and obstructing traffic may be towed away at the expense and risk of the User by authorised services.

V. TERMS AND CONDITIONS OF USE OF THE CAR PARK

- 1. Vehicles may only be parked in designated parking spaces or in areas indicated by the car park attendant.
- 2. It is forbidden to park near entrances, exits, lanes, crossings, pedestrian crossings, as well as places marked with a "NO PARKING" sign.
- 3. Users are required to respect road signs (vertical and horizontal) and other terms and conditions of use of the car park and to follow the instructions of the Operator's security staff and other marked staff members.
- 4. The Operator shall have the right to refuse entry of a vehicle in situations justified by security, safety or organisational reasons, including in particular the lack of available parking spaces.
- 5. A storage contract within the meaning of Article 835 et seq. of the Civil Code of 23 April 1964 is not concluded between the User and the Operator. The car park user is obliged to protect the motor vehicle and the movable property in the motor vehicle against theft and damage. Kopalnia Soli "Wieliczka" S.A. shall not be held liable for loss of or damage to motor vehicles or items left in the motor vehicles parked in the car park.
- 6. Any complaints regarding the concluded rental agreement can be submitted in writing or to the Operator's e-mail address. The complaint must include at least the registration number of the vehicle, the date of parking and the contact details of the complainant. The Operator shall respond to the complaint within 14 days of receipt in writing or by e-mail.

VI. SAFETY REGULATIONS

- 1. The provisions of the Act of 20 June 1997 Road Traffic Law, its executive acts and other generally applicable legal Terms and Conditions are in force in the area of the car park.
- 2. A speed limit of 10 km/h is enforced on the premises of the car park.
- 3. Users are forbidden from bringing weapons, dangerous materials and illegal substances to the car park premises.
- 4. On the premises of the car park, the following are strictly forbidden:
 - a) smoking, the use of open flames, consuming alcohol and other intoxicants;
 - b) storing fuels, flammable substances and empty fuel containers;
 - c) refuelling of vehicles, with the exception of charging of electric vehicles;
 - d) parking cars with the ignition switch on, lights on, open windows, doors or boot;
 - e) parking of vehicles with visible leaks;
 - f) leaving children or animals unattended in the motor vehicles;
 - g) carrying out any promotional or advertising activities on the premises of the car park without the consent of the Operator;
 - h) repairing, washing or vacuuming the motor vehicle, as well as carrying out other works that may pollute the car park area.
 - i) taking off and operating drones and other flying devices;
 - j) parking in spaces for drivers with disabilities in the case of vehicles not entitled to do so;
 - k) leaving waste;
